## Code of Conduct for the Students of Premier University

### Introduction

It is necessary for every human being to be humane in his thinking, behavior and action. He/she will seek truth and be ready to sacrifice his/her comfort, nay (for higher class) life for the betterment of this world. This is more so for a person who is a student of this Alma Mater.

While (they are being) admitted in to the various programs of this university, each student and his guardian shall have to sign a code of conduct promising and declaring that they shall observe the code of conduct of this University faithfully.

### Code of Conduct

1. I (student) shall abide by the academic and administrative rules and regulations of the university and I shall not commit any act subversive of the rules and regulations of the university.
2. I (student) shall conduct myself in such a way, which is befitting for an honest, sober, dutiful, polite, truthful, pleasing and for a person of honor.
3. I (student) shall not take any sectarian view in any manner and shall be guided by general principles of humanity.
4. I (student) may profess any view on philosophy of life and living but I shall not try to impose those views on others. I shall also remain tolerant and respectful to others views.
5. Whatever political views may I profess; I shall not bring them in the campus/ premises of this University. So long I remain a student of this university; I shall not be associated with any political party. Neither shall I be a member of any sister organization of any political party. Should I do so, the authority of the university shall have the right to expel me from the university after giving me an opportunity of being heard.

6. If any problem I face regarding the academic affairs in which I am concerned directly in this university during my tenure of studentship, I may bring the matter to the notice of appropriate authority of the university in a decent and polite way. But in no way I shall resort to any indecent, impolite, rowdy way. Should I do so, the authority of the university shall have the right to expel me from the university after giving me an opportunity of being heard.
7. This university will try to improve the teaching of the student(s), continually so that they can be the best products in the concerned subject. In this respect the university authority will encourage student(s) to express their opinion regarding teaching quality, and their aid and counseling in the learning by the students in the classes and outside the classes. So the students are advised at first, to consult their teacher(s) regarding improvement of the teaching. If such attempts do not bring desired result they may discuss or bring the matter to the notice of the Chair of the department. If it is solved here, that is good. It is expected that most of the problems will be solved within this stage. If there is some still unresolved, that may be brought to the notice of the university authority through the Academic Dean or the Registrar.
8. As a person of dignity and of humane quality I shall never tell a lie. If at any occasion it is proved that I am in the habit of telling lie, the university authority can record it in my personal dossiers.
9. To my fellow female/male students, my behavior shall always be one of gentle and polite and shall not one of irking which is semblance of teasing or annoyance. If I do so I shall be liable for punishment.
10. If there is any grievance by one student against any other student, none can take law into his hand. No student can misbehave with any other student, teacher, officer, staff of this university. If he/she does so, he/she shall be liable to be expelled from this university and he/she will be given no credit. Any student aggrieved will lodge complaint to the Assistant Director, Student Affairs, who in his turn will place it before the appropriate authority.
11. I (student) shall vow to protect properties of the university, to take care of them, to see that lights and fans are off at the end of class, to take care of the book of the libraries while they are in my possession and to uphold the good will of the university everywhere.
12. I (student) shall not be associated with any kind of procession, violence, unlawful meeting, any meeting within the university campus without permission of the university authority. Should I do so, the authority of the university shall have the right to expel me from the university after giving me an opportunity of being heard.

13. Smoking or any kind of use or carrying of drug/arms is strictly prohibited in this Campus. If any kind of drugs or arms found in possession of any student, he/she shall be expelled from the university after giving him an opportunity of being heard.
14. The student shall try to live simple and think high. He will try to keep his study/living room/bed room tidy. He will wash his clothes himself if not constrained by diseases or other factor. He should not waste his time gossiping with friends. He should wholly and fully devote his time in studies. He shall keep in mind that " a well-learned man is always self learned". He will deeply respect his father, mother, teachers and seniors.
15. Cleanliness is very important to lead a healthy life. Students will try to maintain and improve cleanliness in places and surroundings of such places where he/she lives.
16. This institute encourages the guardian of the student to contract students' affairs division of this university to know regarding students' attendance and active participation of his/her ward.
